

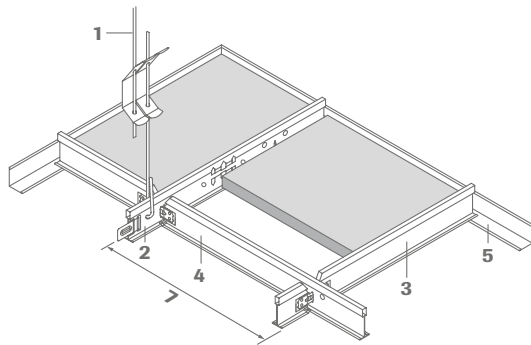

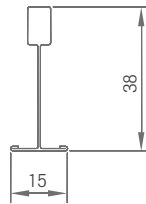

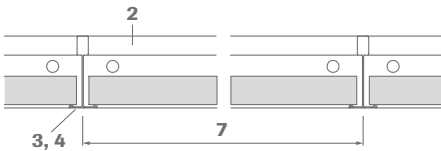
- 1 Hanger no. 12/.../... galv.

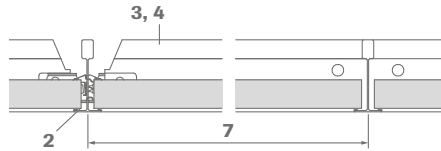

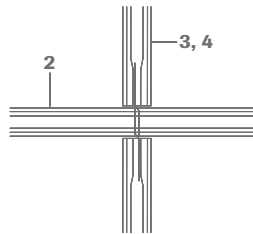

### Construction:

Cross tees are fitted with connection tabs at each end that are inserted into the corresponding vertical slots in the stalk of the main tee. As the tabs are „handed“ care must be taken to ensure each cross tee is inserted into the correct side of the slot (see diagram). Main tees are joined together using the integral locking, offset, end connectors.

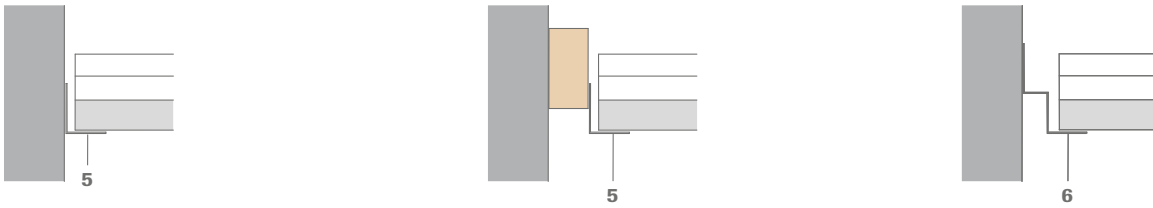

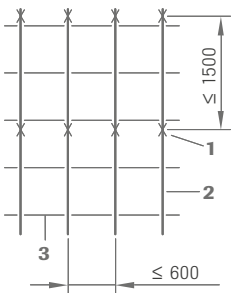
Minimum suspension depth 75 - 100 mm (from underside of soffit). For ease of panel removal 120 mm is recommended.

### Exposed grid OWAacoustic® System S 15 (Lay-in system)

#### Quality Statement:

OWAacoustic mineral panels are free from harmful materials such as asbestos and formaldehyde. A statement from the German institute for Building Technology is available. The mineral wool used in these panels is biodegradable. The criteria of the zero-ranking as a carcinogenic material in the chemical prohibition ordinance (§ 1 appendix) section 23 bio-persistent fibres are complied with and therefore carries the "RAL-Seal of mineral wool" guarantees.
